LAND TRUST- Initially we were given \$29,000 but the amount was increased to \$32,628 due to diagnostic Kindergarten. The amount is based upon school enrollment. Everyone at meeting was given a copy of the CSIP plan to review. Land Trust money pays for 3 reading interventionists and 1 math interventionist. Also pays for subs for teachers to do walk throughs and observe other teachers. Some Chrome books will be purchased to help with education in higher grades. BJ will update us every month on spending progress. Our goal is to spend 10% per month so that all money is used this year on students.

SCHOOL GRADE- Canyon View received an “A” on its School Grade. Review of results by BJ that led to this grade. Usage of Land Trust Money helped us to achieve this grade.

BELL SCHEDULE PRESENTATION – There is a shortage in bus drivers. We are not able to keep drivers employed due to not being full time positions and not having benefits. Study was

done on how we could make bus driving positions full time by changing bell schedules by a matter of minutes throughout the district. Many busses would be eliminated completely and positions would be full time for drivers. Specific options for Canyon View include:

9:00-3:35 OPTION #1

8:55-3:30 OPTION #2

Questions and concerns: What would working parents think about these later start times? How would it affect the afternoon drop off time for bus riders? Butler Middle would start 5 minutes later and Brighton would start 20 minutes earlier. With the money that is saved could we have morning programs for schools for early drop offs? If they do decide will they give us the changes with an ample amount of lead time?
