Final Report 2014-2015-

Review Current Budget

Amendment due to increased funds

We were originally allocated \$25,000 and the final amount was bumped up to \$30,510 for this school year. Our plan submitted has every dollar going to the hourly wages of interventionists (3 reading and 1 math). We will have \$2800 excess. BJ Weller proposes that one teacher from each grade be sent to explicit teacher training with Anita Archer. That will cost \$75 per teacher sent and the cost of a ½ day sub to cover the teacher's absence. The total cost will be approximated \$1,000. BJ Weller also proposes that we use approximately \$800 to purchase incentives for the Bengal Bucks Store as part of our PBIS. That will leave approximately \$1,000 to carry over for next year. BJ Weller will draw up an amendment laying out the plan above stated for how we will use the excess funds.
