INTRODUCTIONS:

Everyone introduced themselves and stated their position on the council. (See attendees listed above.)

BUSINESS:

Land Trust \$\$ Increase- We are looking at a possible 15% increase in the amount of Land Trust money we will receive this year. That could equate to a few thousand extra dollars for the year. Currently the money is being used to pay for 3 reading intervention aides and 1 math intervention aide. The increase in money could mean that we could keep the aides working for a longer amount of time. Normally the aides have to stop working in May but this may allow them to work through the entire school year. BJ Weller will keep us updated on how much money we have as the year goes on.

Safe Walking Route- Hazardous bussing routes have been cancelled this year for Canyon View. Approximately 55 students are affected by this. The current construction that is ongoing on the sidewalks is partly in order to make more safe walking routes. We are still looking into how Danish and Creek Rd can have a safe walking route. We need to re-submit the signature page for the safe walking route and that was completed by members present. We are looking into requesting the city paint crosswalks in intersections that are used by students. We will be submitting requests to the city to ensure safe walking routes for all Canyon View students.
